1. Each entry must include the following:
 1. Completed entry form (photocopy is acceptable) with original signature.
 2. Musical Jingles submitted in the following format: MP3. You will need to submit the lyrics typed or written legibly with your entry.
 3. Video commercials submitted in the following format: 640X360 resolution MP4. You will need to submit the script typed or written legibly with your entry.
 4. Please include your email address and contact details on the lyric sheets and scripts. Do not send sheet music with your entry.
 5. **Commercial must be 30 seconds or less in length.**

2. All entries submitted must be original and shall not infringe any copyrights or any other rights of any third parties. All entries may have multiple co-writers, but only one name should be designated on the entry form. Entrant shall, by entering, indemnify and hold Helen O'Grady Drama Academy harmless from and against any claims inconsistent with the foregoing.
3. Competition is open to all amateur and professionals and anyone regardless of nationality or origin. Employees of Helen O'Grady Drama Academy, its families, subsidiaries and affiliates are not eligible. If entrant is under 18 years old, the signature of a parent or guardian is required.
4. Entrant may submit as many jingles / video commercials as desired in each category. It is entrant's responsibility to ensure that the submitted song(s) are complete and playable. **Helen O'Grady Drama Academy does not give feedback or a critique to entrants.**
5. Helen O'Grady Drama Academy is not responsible for late, lost, damaged, misdirected, incomplete, or misappropriated entries.
6. Entries close on Saturday 27th September 2014. The Helen O'Grady Drama Academy reserves the right to extend the entry deadline.
7. Entries will be screened by a Helen O'Grady Drama Academy listening committee who will select the finalists.
8. All prizes will be awarded to the first name as it appears on the entry form, and division of prizes among co-authors is the responsibility of winners. Entrant agrees to accept the final decision of Helen O'Grady Drama Academy and its judges.
9. Voting lines will be open from Monday 13th October 2014 and the Winner will be announced on Monday 27th October 2014.
